WELCOME TO THE INN AT BATH!

Housed in a beautiful old Greek Revival home in the historic district...and originally built in the 1840s...The Inn at Bath provides comfortable accommodations for discerning guests and is surrounded by gorgeous perennial gardens with a partial view of the water.

The Inn has 7 well appointed guest rooms, all with en-suite baths, some with private exterior entrances. The custom kitchen is open and airy with stone counters, a Bluestar gas range/oven, hood and additional wall oven. There is large, sunny dining room and 2 parlors for guests' use. There are 5 wood burning fireplaces and two Jacuzzi tubs in the inn, and 1 gas fireplace. Additionally...just off the kitchen...there is a two room owner/innkeeper's quarters with two baths and separate entrance. The stone patio is a wonderful gathering place at any time of day.

In the past, this inn had operated as an 8 room inn for guests, and could even be configured to 9 guest rooms with private baths (see layout attached). Just a short stroll down Washington Street...this lovely inn is within an easy walking distance to Bath's downtown shops, restaurants, galleries and museums. This is a turnkey business, just awaiting its new owner!
























THE OWNER'S QUARTERS OPTIONS

LOCATION


Bath is centrally located in Maine's southern/midcoast region...and a perfect destination to use as home base while exploring the area.

The inn is located:

- 40 minutes from Portland
- 15 minutes from Bowdoin College in downtown Brunswick
- 2.75 hours from Bar Harbor and Acadia National Park
- 45 minutes from Boothbay Harbor
- 1 hour from Camden
- 2.5 hours from Boston
- 35 minutes from Reed State Park, Georgetown



Known as the "City of Ships" for its storied history of all the sailing vessels that were built in the Bath shipyards...and currently home to the Bath Iron Works and the popular Heritage Days Festival...this beautiful midcoast destination has a vibrant downtown historic district that is well known for its 19th century architecture, shops and art galleries. The city of Bath includes several nature preserves that are protected by the Kennebec Estuary Land Trust, and its proximity to Boothbay Harbor, Brunswick, Portland and the stunning Maine coastline...make it a location that has long been popular with tourists.
